### Hurricane Matthew hits Darlington County

"As soon as Hurricane Matthew's fierce winds subsided, work crews all over Darlington County fanned out to assess the damages and begin the daunting cleanup process.

The Darlington County Emergency Operations Center activated Thursday, October 6 at 7 a.m. to prepare for Hurricane Matthew. All county first responders coordinate through EOC during times of emergency.

"There is still a lot of danger," said Sheriff Wayne Byrd. "Power is still off in the majority of areas. Avoid the dangers - stay off the roads."

#### President declares disaster for Florence County, State of South Carolina and 12 other counties

"COLUMBIA, S.C. - In response to Governor Nikki Haley's request, President Barack Obama declared a major disaster exists in the State of South Carolina and ordered Federal aid to supplement state and local recovery efforts in 13 counties most severely affected by Hurricane Matthew.

The Federal Emergency Management Agency Public Assistance Program helps reimburse local governments, state agencies, eligible private non-profit organizations and electric co-operatives for certain expenses they have incurred. Federal disaster aid is not available for individual residents at this time.

On October 10, Governor Haley formally requested a disaster declaration from the White House for Beaufort, Berkeley, Charleston, Colleton, **Darlington**, Dillon, Dorchester, Florence, Georgetown, Horry, Jasper, Marion, and Williamsburg counties. Her request followed an assessment of damages by representatives of the South Carolina Emergency Management Division, the Federal Emergency Management Agency, affected electric co-operatives, and local and municipal governments."

## Darlington County Progress Annual Meeting

September 29, 2016

Darlington County Progress held its annual meeting at the SiMT conference center on September 29, 2016 with guest speaker, Jack Shuler, of the Palmetto AgriBusiness Council.

Mr. Shuler reported that the impact of the agribusiness industry including forestry and agriculture was \$42 billion in South Carolina. He noted that Darlington

County was well-suited to expanding agribusiness as a target industry due to the abundant water and experienced workforce. He remarked that as food processors moved closer to their markets to improve freshness and limit contamination from older facilities, the food industry would look for new facilities close to rail and interstates. Darlington County was well-positioned to provide those needs as shown by other food processors that had already moved to the Pee Dee Region.

Five board members were re-elected to new terms including Roger Buckley of Sonoco, LaJuan Davis of JBE, Inc., Curry Dawkins of Dawkins Concrete, John Nichols of First Citizens Bank and Kerry Tharp of Darlington Raceway.
