Investment Policy








Specific Risk	
Default Risk	The risk that the issuers of fixed income instruments (e.g. bonds) may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality it vital. The wors the credit quality, the greater the risk of default and therefore investment loss.

Maximum Drawdown	Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.
Maximum Gain	Max Gain: Largest increase in any single month

Average Duration	The weighted average duration of all the underlying interest bearing instruments in the Fund.
Average Credit Quality	The weighted average credit quality of all the underlying interest bearing instruments in the Fund (internally calculated).
Dividend Yield	The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

High Water Mark	The highest level of performance achieved over a specified period.
Fund Risk Profile	Generally, high risk/aggressive portfolios hold more equity exposure than lower risk/conservative profiled portfolios.
