

### Investor Profile

The PMK Global Flexible Prescient Fund of Funds is suitable for investors seeking to invest in offshore markets to achieve returns that are in excess of inflation by taking a relatively higher degree of risk with the aim of capital growth over the long term. Investors should be comfortable with market fluctuations and willing to accept potential capital losses. The Fund is suitable for investors who have an investment horizon of five years and longer and aim to build wealth by investing in a portfolio that diversifies the risk over the various offshore asset classes.

### Investment Objective

The Fund will aim to achieve performance returns in line with the South African Consumer Price Index plus 5.5% over rolling 5-year period. It will seek to capture relative value opportunities by switching between asset classes and will further focus on geographical spread and manager selection opportunities.

### Investment Policy

In order to achieve the objective, the Fund will, apart from assets in liquid form, consist solely of participatory interest in collective schemes or similar schemes which will invest in a diversified mix of global assets, including equities, bonds, fixed income, property, preference shares, money market instruments and listed and unlisted financial instruments as determined by legislation from time to time. The asset allocation will be actively managed with exposure to various asset classes, countries and regions being varied to reflect changing economic and market circumstances, to maximize returns for investors. The portfolio can invest across various jurisdictions and markets subject to the investment conditions determined by legislation from time to time. Where the aforementioned schemes are operated in territories other than in South Africa, participatory interests or any other form of participation in these schemes will be included in the portfolio only where the regulatory environment is to the satisfaction of the manager and trustee and is of a sufficient standard to provide investor protection at least equivalent to that in South Africa.

**Adherence to the investment objective:** The Fund adhered to the Investment policy objective for the quarter.

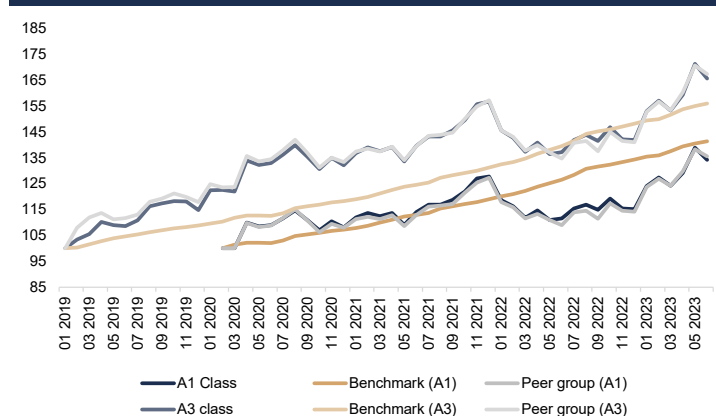

Specific Risk	
<b>Default Risk</b>	The risk that the issuers of fixed income instruments (e.g. bonds) may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

<b>NAV</b>	The net asset value represents the assets of a Fund less its liabilities.
<b>Alpha</b>	Alpha: Denoted the outperformance of the fund over the benchmark.
<b>Sharpe Ratio</b>	Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.
<b>Standard Deviation</b>	Standard Deviation: The deviation of the return stream relative to its own average.
<b>Maximum Drawdown</b>	Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

<b>Fund Risk Profile</b>	Generally, high risk/aggressive portfolios hold more equity exposure than lower risk/conservative profiled portfolios. High risk portfolios therefore tend to carry more volatility and expected potential long-term returns could be higher than other risk profiles, in turn potential losses of capital could be higher. For low risk /conservative portfolios, expected potential returns could be lower but with less volatility.

Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER. The Fund's asset allocation has been calculated based on the latest available Morningstar data for the underlying Fund holdings. Morningstar data is updated either monthly or quarterly depending on the availability of data for each underlying collective investment scheme. The asset allocation may differ from time to time due to market movements and portfolio limitations.

Performance has been calculated using net NAV to NAV numbers with income reinvested. The performance for each period shown reflects the return for investors who have been fully invested for that period. Individual investor performance may differ as a result of initial fees, the actual investment date, the date of reinvestments and dividend withholding tax. Where a current yield has been included for Funds that derive its income primarily from interest bearing income, the yield is a weighted average yield of all underlying interest bearing instruments as at the last day of the month.
