Investment Objective

The Fund is designed to deliver a real return of US CPI +4.5% net of fees over the long term, with an appropriate level of risk.

Investment Policy

The Fund intends to achieve its investment objective by investing globally, primarily via other collective investment schemes, in a wide range of asset classes including cash, fixed income, equities, property, commodities and asset allocation portfolios. The Cell may also invest in transferable securities which are classes of investments that are negotiable on a capital market such as (but not limited to) shares in companies or bond investments.








Default Risk	The risk that the issuers of fixed income instruments (e.g. bonds) may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality it vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Maximum Drawdown	Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Fund Risk Profile	Generally, high risk/aggressive portfolios hold more equity exposure than lower risk/conservative profiled portfolios. For low risk /conservative portfolios, expected potential returns could be lower but with less volatility.
