

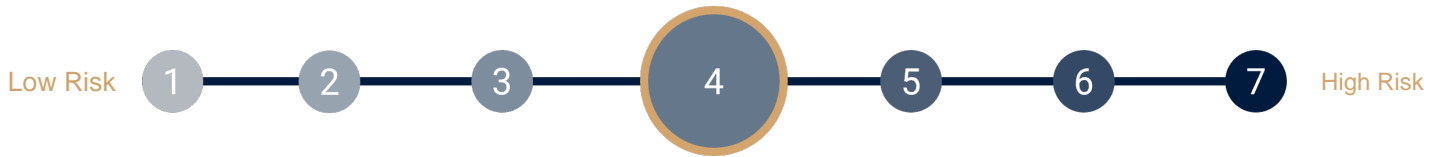
### Strategy

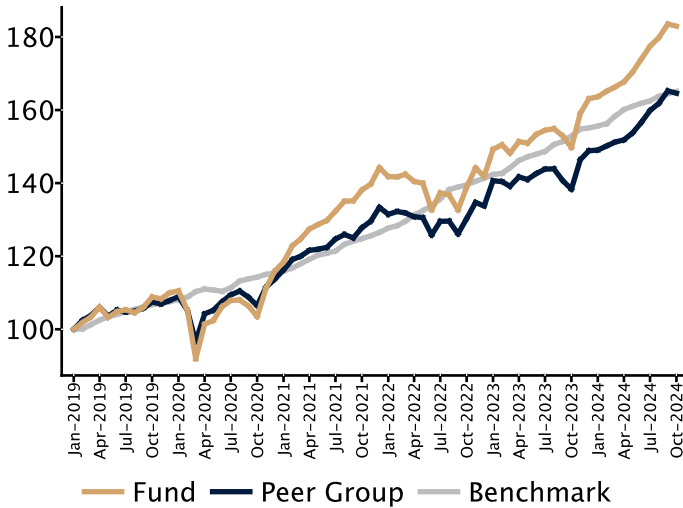
