

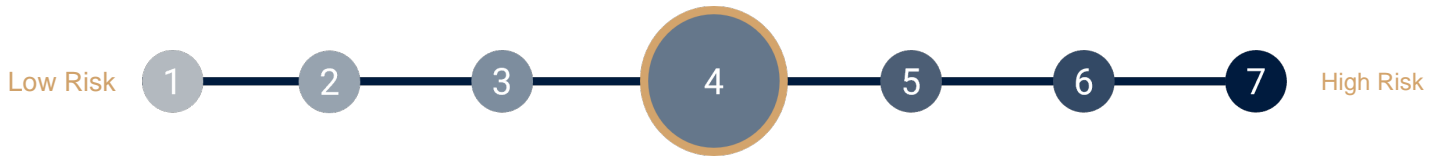
Strategy

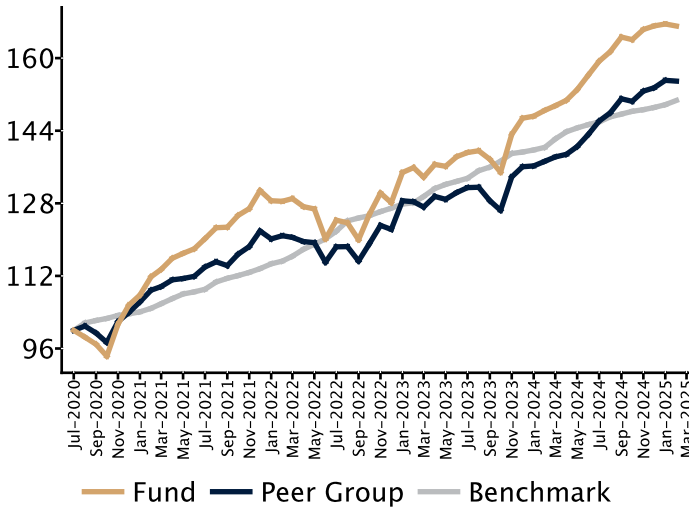
