The Low-Cost Spay/Neuter Clinic performed 4,225 spay/neuter surgeries preventing an estimated 25,000 unwanted pets entering area shelters. Through low-cost vaccines, thousands of area residents received life-saving vaccines.

SSHS again broke all adoption records placing 2,739 pets, transferring 356 pets out to rescue for a total life-saving percentage of 94%.
