The Low-Cost Spay/Neuter Clinic performed 9,309 spay/neuter surgeries preventing an estimated 38,000 unwanted pets entering area shelters. Through low-cost vaccines and free microchipping at the time of surgery, thousands of area residents received life-saving vaccines.

South Suburban Low Cost Veterinary Services Clinic

The SSLCVSC saw 14,608 patients helping these pets to stay with the pet parents who love them.
