The Low-Cost Spay/Neuter Clinic performed 10,343 spay/neuter surgeries preventing an estimated 38,000 unwanted pets entering area shelters. Through low-cost vaccines and free microchipping at the time of surgery, thousands of area residents received life-saving vaccines.

South Suburban Low Cost Veterinary Services Clinic

The SSLCVSC saw 20,962 patients helping these pets to stay with the pet parents who love them.

SSHS took in 4,420 animals, placed 3,608 pets through adoption, transferred 121 out to rescue, and returned 426 lost pets to their owners for a total life saving percentage of 94%
