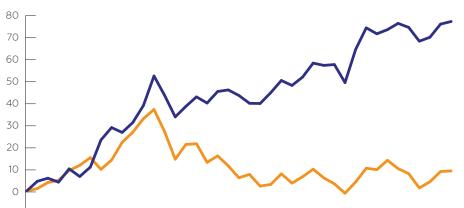
Investment objective
