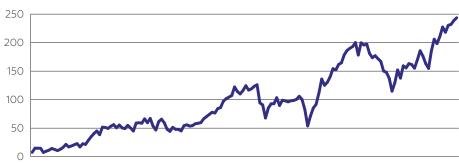
Investment objective
