

# HOSPITALITY RIDER – 2026

## 1. GENERAL REQUIREMENTS

All items listed in this Rider are mandatory unless otherwise agreed in writing. The Promoter agrees to provide all hospitality, technical and logistical needs as outlined below, in accordance with the Performance Agreement.

## 2. DRESSING ROOM REQUIREMENTS

A private dressing room exclusively for the Artist and crew must be provided.

The room must include:

- Private toilet (en-suite or immediately adjacent, not shared with public).
- Full-length mirror
- Standard mirror
- Table
- Comfortable seating for minimum 4 people
- Adequate lighting & heating/cooling
- Clean, secured room accessible only to Artist and authorized team
- Power outlets for phone charging & make-up

## 3. HOSPITALITY – FOOD & DRINKS

Beverages

Promoter agrees to provide the following, chilled unless stated otherwise:

- 2 bottles of premium champagne (Moët, Veuve Clicquot, pommery)
- Still water (flat water)
- Cola Zero
- Ice-Tea (original)
- Room-temperature water bottles on stage for the Artist
- Minimum 6 bottles

#### Snacks & Food

- Fresh mixed sandwiches (vegetarian option included)
- Assorted snacks (chips, salted nuts, M&M's)
- Fresh fruit platter (seasonal fruit, ready to eat)

All items must be available in the dressing room no later than the start of soundcheck.

#### 4. TECHNICAL HOSPITALITY

In line with the Performance Agreement, Promoter guarantees:

- Professional sound system suitable for dance performance
- In-ear monitoring system AND stage monitors
- A full soundcheck prior to showtime
- Free stage and venue access for Artist's cameraman (on and off stage)

#### 5. SECURITY

- Minimum 2 security guards at the stage.
- 1 guard upon arrival & departure + escorting to/from stage.
- No unauthorized persons allowed backstage or on stage.

#### 6. PARKING & ACCESS

- Private transport with personal driver between hotel and venue (round trip).
- Reserved parking space near the artist entrance.

#### 7. ARTIST TEAM

- Jessy (Artist)
- Videographer / Tour Manager

#### 8. STAGE REQUIREMENTS

- Minimum dimensions: 4 m (width) × 3 m (depth) × 0.40–0.60 m (height).
- Clean, safe, dry, nonslippery stage.
- No props, sets, or technical materials on stage. • Backdrop if available.
- Safe and easy stage access.

## 9. SOUND REQUIREMENTS

- Professional PA system (Coda Audio, d&b; audiotechnik or equivalent).
- Minimum 2 monitor speakers with independent mixes.
- Vocal microphones: 2 × Shure QLXD H51 required.
- Artist brings her own inear systems: 2 × Shure PSM900 G7E — compatible frequencies required.
- Free stage + venue access for videographer (on/off stage).

## 10. LIGHTING

- Professional front & back lighting.
- Pressshow consultation for possible lightshow.
- NO white light and NO smoke machines — crucial for video recordings.

## 11. TRAVEL INFORMATION

- Flights booked by Artist — reimbursed by Promoter via advance payment.
- Promoter covers:
  - 2 flexible direct return flights (Brussels Airport or other if multiple bookings).
  - Priority boarding for 2 persons.
  - Seats in first 3 rows.
  - Extra luggage when required.

## 12. ACCOMMODATION

- Minimum 5star hotel \*\*\*\*\* (preferably with indoor/outdoor pool + gym).
- 2 × nonssmoking doublesbed rooms unless otherwise agreed.
- Late checkout must be possible.
- €50 per room per night covered by Promoter.

## 13. TRANSFERS

- Airport → Hotel
- Hotel → Venue
- Hotel → Airport

#### 14. PROMOTION & MEDIA

- Promoter may use only official promotional photos and footage provided by the Artist.
- No third-party images or edits may be used without written approval.
- Cameraman belonging to the Artist must have free access in all performance areas.

#### 15. STAGE HOSPITALITY

- Room-temperature water bottles must be placed on stage before the show.
- Stage must be clean, safe, and free of obstacles.

#### 16. ACCEPTANCE

This hospitality rider is an integral part of the Performance Agreement 2026.


By signing and confirming the booking, the Promoter acknowledges full acceptance of all requirements listed.

#### EXTRA CONDITIONS


- All itineraries must be approved by Jessy before booking.
