1. Infinity Community Abundance Society - Mission Statement

After arriving at landing page to join the Infinity Community, you will be prompted to connect a TronLink Web 3.0 wallet to access the Infinity Community Services; and before joining the Infinity Community, you must accept the founding documents, including Infinity Community Abundance Society - Privacy Policy and Infinity Community Abundance Society - Swap Terms of Use; and then to send accepted amount of token to join Infinity Community, and use the Infinity Community Services.

1. The Infinity Community Service for Swaps

The Website is a user interface designed to provide convenient access to software comprised of a set of smart contracts deployed to the TRON public blockchain that allow for the creation of swaps of Infinity Coin for other Digital Tokens that are paired on a selected Pair Swap Pair (Swap Pair) - These Smart Contracts are also accessible by direct access on the TRON blockchain at https://tronscan.io. Infinity Coin, TRON, and other Digital Tokens ("Tokens") can be given to a supply a Swap Pair contained in the smart contract ecosystem on a fully permissionless basis by any member, and any other member that receives/takes (Gets), may access this supply by swapping Digital Tokens from a Swap Pair. Infinity Community developed Swapping Technology ("Infinity Community Service") and deployed ("Deployment") the Smart Contracts that can be used to create and operate swaps, but Infinity Community does not and will not create or operate any swaps itself and does not and will not itself have the authority to modify or update the Smart Contracts. Because the Smart Contracts are, on Deployment, deployed on a blockchain, they may also be accessible now or in the future through other TRON-based smart contract decentralized applications ("Dapps"). On Deployment, the TRON address associated with the Smart Contracts holds no Digital Tokens. The Website and related technology allows a user/Member to read and display data associated with a blockchain address for which that Member controls the associated private key and to interact with the Smart Contracts by generating standardized transaction messages in order to engage in swap transactions by accessing the swaps created using the Smart Contracts or to create or provide supply to such swaps. 1.1 Token Provider Factors.

The Provider are the Members that Provide their Token to the Swap Pair for Swapping at the rate set, although the rate may be restricted by algorithms designed to maintain Token stability. The Token Provided maybe removed from a Swap Pair if the rate is outside a designated range of the evaluated rate, and also place on the Swap Pair again if the rate is within the evaluated rate. Only one Pair of Token at one Rate can be placed on the Swap Pair at a time by a Provider. The Swap can be canceled at any time by the Provider. No Mining Activity Points are obtained at the time the Token is placed on the Swap Pair. The Activity Points are only distributed to the Provider when someone ("Receiver") Receives Token from the Swap Pair. The Smart Contracts may also place limits on the available range for certain Token pairs, but it will not control the rate set by Provider.

1.2 Swapping Fees.

There are two categories of fees can occur, both of which may be reduced to zero fees.

(i.) TRON Blockchain and Smart Contract Fees.

The TRON Blockchain fees are for Bandwidth and Energy usage. TRON used an Proof of Stake consensus model, which provides a Member the ability to stake TRON (TRX) to obtain a supply of both Energy and Bandwidth separately. With sufficient staked amounts of TRON, the use of the Blockchain and Smart Contract can be completely covered with zero fees for a Swap. The Blockchain and Smart Contracts access fees can change from time to time based on blockchain usage and staking conditions. In order to access the Smart Contracts to engage in transactions using the Website or Direct Access, a Member must first connect a TronLink wallet ("Wallet") to the Smart Contracts.

2. Swap Participants

2.1 Future Swap Pairs.

The Infinity Administration from time to time may add or remove custom Swap Pairs, and will use the website and Smart Contracts to create customized swaps containing Infinity Coin Token and TRON or other Digital Tokens pairs and add these pairs to Infinity Community System, and to the Swap Pair Supply to swap. These Custom pairs may allow for swapping by third parties that are not members of the Infinity Community from the Swap Pair. Administration will be able to set the desired rate or the system that determines the rate for the Token of the Swap Pair. The Swap Pair Swapping Fee will be determined programmatically by the Smart Contracts when the Receiver Status is established. Once these variables have been determined and the smart contract for the available Swap Pair has been launched, and the initial supply of Token for the Swap Pair, the Swap Pair can begin.

2.2 Provider's Swap Pair Supply.

Providers can increase their available supply to create their Swap Pair Pairs by sending Token, TRON, or other relevant Digital Tokens from their TronLink Wallet to their Infinity Community available Supply. The smart contract holds this balance ready for the Provider to create a Supply Swap Pair in any proportion and rate for the Digital Tokens in the Provider's Supply at that time.

2.3 Receivers.

Receivers can execute token swaps involving the Token for Digital Tokens in swaps, allowing them to swap an amount of one Digital Tokens for an amount of Token. Receivers accomplish this by specifying which Available Supply Swap Pair created by a Provider they choose, and by inputing the amount of Token, to swap for, and the amount of TRON or Digital Tokens is determined programmatically by the Smart Contracts based on the Providers implied rate set for the selected Supply Swap Pair.

2.3.1 Swap Activity Points

All Members will receive Activity Points to increase their mining points through the activity of swapping on the website. Those individuals that are not members will be able to swap through direct access of the smart contracts will not receive any points, neither as a Provider or Receiver.

2.3.2 Swap Points

The activity for the Provider and Receiver generates an amount of Swap Points based on a formula for that type of Swap and applies to all swaps completed by any Receiver.

2.4 Swapper Program

Any Member can join the Swapper Program. The Swapper Program is for those that want to contribute to the value of Token by building swapping Swap Pair with large groups of people that they will provide Token to and receive addition Token through enhanced Points multipliers "Multi(s)" applied to their received Pockets as well as from Points Matching for those direct team that joined them.

2.4.1 Swapper Catches

A Pocket-Swap is a set of Token received for an amount of TRON. The supply of Token used for Catches is limited to mined Token from a block from the DEX opperations side of the Token mining process. As long as there is available supply of Token, at any one time their will be one or more Catches available to be selected. Each available Pocket has a Amount and a Level. The Amount indicates an amount of TRON required to Get that Pocket. The Level indicate the number of the Pocket in a list in which as the Level increases the Amount also increases. The typically amounts of 1000, 3000, 5000, 10000 can be listed. There can be any number of levels of Catches. These Levels and Amounts and how many are made available for a Swapper to Pocket can change at any time. Some Catches are one time promotions such as the First Get promotion that is only available at Swapper Sign Up for 100 TRON. Others promotional catches may be listed for events and run for a periode of time.

2.4.2 Pocket-Swap Points

Swappers, have exclusive access to Token Catches and will receive additional Points for the current Token mining block. The Swapper benefits exponentially grow your Points from several Multipliers "Multi's". The reward for consistent Swapper Activity is an exponentially growing percentage of the curent mining block of Token. Only Swappers can Get Catches of Token. Swapper Multipliers "Multi's" are applied to Swapper Activities of getting Catches. All Multi's are applied to the amount of TRON in the selected Pocket. Each Pocket has a SizeMulti that can be any number determined by a number of TRON required to Get that Pocket.

There are 3 Multi's that Increase your Pocket Points.

i. CatchMulti

Increases by 1 for each Pocket obtained in a Mining Block. Including if the First Pocket Sign Up is Taken the Pocket Multi is 1. When the next Pocket is Taken the CatchMulti will then be 2, and the CatchMulti will continue to increase until the mining of the current Block is complete and the CatchMulti will reset to zero and will increase to one when the next Pocket is Taken.

ii. BlockMulti

Increases by 1 for each consecutive Block a Pocket is obtained. When the first Pocket is Taken the BlockMulti will increase to 1, and will only increase to 2 if a Pocket is Taken is the following Block. The BlockMulti will continue to increase by 1 as long as a Pocket is Taken. If a Pocket is not Taken is the follow Block then the Block Multi is reset to 0 and increases to 1 after a Pocket is Taken.

iii. SizeMulti

When a Pocket is selected, the Level of the Pocket determines the SizeMulti. Each Level has a different SizeMulti and these Size Multis can be any number and different or the same for whichever Level that that SizeMulti is listed on. Typically the SizeMulti will increase with the Amount, but promotional SizeMultis can be listed that would make every level the same SizeMulti, or one of the listed may higher for a period of time.

2.4.4 SunSwap

SunSwap is a TRON-based decentralized trading protocol for automated liquidity provision and an open swapping system accessible to all. SunSwap supports secure and immediate exchange between any TRC20 tokens. TruSwap+ does not have any control as to what happens on SunSwap other than the creation and maintaining a liquidity pool for Token. The link and SunSwap price that appears on the TruSwap+ website is for the convenience of our users. The SunSwap price for Token is also used to have a 24 hour rolling average and is hourly updated to determine the rate Token Catches Taken by Swappers.

This includes taking advantage of software vulnerabilities and any other act that intentionally abuses or exploits the design of the Infinity Community Services.
- 3.7 You represent and warrant that you are sophisticated in using and evaluating blockchain technologies and related blockchain-based Digital Tokens, including the TRON network, smart contract systems, TRC-20 tokens, automated market making protocols, and automated lending protocols. Specifically, you represent and warrant that you have evaluated and understand the operation of the Infinity Community Services and the swaps using the Smart Contracts and have not relied on any information, statement, representation, or warranty, express or implied, made by or on behalf of Infinity Community with respect to the Infinity Community Services and associated swaps.
- 3.8 All of the above representations and warranties are true, complete, accurate and not misleading from the time of your acceptance of the Infinity Community Terms and are deemed repeated each time you use the Infinity Community Services.

4. Prohibited Use

Users of the Infinity Community Services may not, directly or indirectly, engage in any of the following activities in connection with their use of the Infinity Community Services ("Prohibited Uses"):

- 4.1 A violation of any law, rule, or regulation of any jurisdiction that is applicable to the Member;
- 4.2 Violations or breaches of the terms of these Infinity Community Terms or any other document from time to time governing the use of the Infinity Community Services;
- 4.3 Permit others to access the Infinity Community Services through your wallet or a blockchain address you control or otherwise engage in transactions using the Infinity Community Services for any person other than the Wallet owner;
- 4.4 Perform, or attempt to perform, any actions that would interfere with the normal operation of the Infinity Community Services or affect the use of the Services by other users;
- 4.5 Engage in, or knowingly facilitate, any fraudulent, deceptive, or manipulative transaction activity in any Digital Tokens using the Infinity Community Services, including by engaging or participating in "front-running", "wash swapping", "pump and dump schemes", or similar activities;
- 4.6 Engage in, or knowingly facilitate, any money laundering, terrorist financing, or other illegal activities;

- 4.7 Access or attempt to access non-public Swapping Technology systems, programs, data, or services;
- 4.8 Copy, reproduce, republish, upload, post, transmit, resell, or distribute in any way, any data, content, or any part of the Infinity Community Services except as expressly permitted by applicable laws; and
- 4.9 Reverse engineer or attempt to reverse engineer the Infinity Community Services except as expressly permitted by applicable law.

5. Waivers

- 5.1 You agree and acknowledge that Infinity Community and its Associates shall not be liable for any direct, indirect, special, incidental, consequential or other losses of any kind, in tort, contract or otherwise (including but not limited to loss of revenue, income or profits, and loss of use or data), arising out of or in connection with your use of the Infinity Community Services. For purposes of the Infinity Community Terms, "Associates" means the owners, directors, officers, staff, advisors, miners, team members, agents of Infinity Community or companies in which Infinity Community has an interest, or any associated companies (Infinity International Development LLC).
- 5.2 You agree not to initiate or participate, and waive the right to participate in, any class action lawsuit or a class wide arbitration against Infinity Community and/or its Members.
- 5.3 By accepting the Infinity Community Terms, you waive all rights, claims and/or causes of action (present or future) under law (including any tortious claims) or contract against Infinity Community and/or its Members in connection with your use of the Infinity Community Services.
