## RESOLUTION OF COMMITMENT TO A VISION ZERO POLICY TO ELIMINATE FATALITIESAND SERIOUS INJURIES THAT ARE A RESULT OF CRASHES IN THE VILLAGE OF KIRYAS JOEL BY 2045

WHEREAS from 2018 to 2022, there were a total of 718 roadway crashes in our Village, representing a substantial risk to all road users and highlighting the urgent need for systematic safety improvements; and

WHEREAS during the same five-year period, there were 30 fatal and serious injury crashes, which emphasizes the need to address traffic safety issues to protect the lives and well-being of residents; and

WHEREAS the number of people dying and suffering serious injuries on our streets is a serious public health problem which necessitates public action; and

WHEREAS crash reduction efforts necessitate a comprehensive and specific approach to street planning, design, policy, enforcement, legal processes, education, and communication; and

WHEREAS the Safe Streets for Kiryas Joel Plan aligns with the 2023 New York State Strategic Highway Safety Plan; and

WHEREAS traveling on the roadway is beneficial to the economy by facilitating trade, enabling commerce, connecting labor markets, and enhancing overall economic productivity; and

WHEREAS, crashes that result in death or serious injury are not inevitable but largely preventable; and

WHEREAS, the Village of Kiryas Joel has taken the proactive approach to develop an effective Safety Action Plan built on a foundation of Safe Systems principles and elements that will translate into evidence-based implementation processes; and

WHEREAS implementing a road safety commitment requires coordination and effort from various departments, all of which have expressed interest and willingness to move toward zero deaths, highlighting the importance of a multifaceted and collaborative approach to traffic safety.

**NOW, THEREFORE, BE IT RESOLVED** that the Village of Kiryas Joel, New York agrees to develop, plan, and program projects that work to achieve a goal of zero fatal and serious injury crashes by 2045.
