The Platform for Action on the Green Recovery of Ukraine (UGRP) serves as a coordinating mechanism between Ukrainian authorities and international partners to ensure environmental and sustainability considerations are integrated into Ukraine's recovery process.

Through consultations with the Ministry for Development of Communities and Territories, Ministry of Economy, and Ministry of Environment and Agriculture, a critical gap was identified: the need for unified green criteria to systematically analyze projects within Ukraine's DREAM platform for Public Investment Management (PIM). As Ukraine advances its PIM reform and prepares for EU integration, there is a need to develop green criteria that are aligned with international frameworks (EU Green Taxonomy, UNECE conventions, environmental and social safeguards) while being practical and implementable in the Ukrainian context.

This workshop will provide an opportunity to present different green criteria to key stakeholders, gather their feedback on practicality and feasibility, understand implementation challenges, and ensure the criteria are both ambitious and operationally viable for integration into the DREAM platform and national PIM processes.
