

# **Public Offer**

## **on Making a Voluntary Charitable Donation**

### **1. General Provisions**

1.1. This public offer (hereinafter referred to as the "Offer") is drawn up in accordance with Article 641 of the Civil Code of Ukraine and is addressed to an indefinite number of capable natural and legal persons of private law (hereinafter referred to as the "Donor").

1.2. The Offer is considered accepted from the moment of its acceptance by the Donor (see Section 6) and is valid indefinitely until revoked by the Organization.

### **3. Subject of the Agreement**

3.1. The Donor voluntarily and gratuitously transfers funds to the Organization in the form of a charitable donation for the purpose of achieving the statutory goals of the Organization. The generation of profit is not the subject of this Agreement.

3.2. At the Donor's discretion, the donation may be targeted (with an indication of the program/project) or general (for statutory activities).

3.3. If the project for which a targeted donation was made is not implemented (e.g., the fundraising campaign is closed or has become irrelevant), the remaining funds will be used by the Organization for other ongoing programs that align with its statutory objectives. By making a payment, the Donor agrees to the possibility of such reallocation of their donation.

3.4. In the event of the Organization's termination (liquidation, closure, or removal from the registry), any remaining unused charitable donations, including those designated for unfulfilled targeted projects, shall be redirected to other charitable or non-profit

organizations with similar objectives, as determined by the authorized governing body of the Organization in accordance with the applicable laws of Ukraine.

Information about such fund transfers will be made publicly available on the Organization's official website or through other accessible communication channels.

#### **4. Procedure for Making a Donation**

4.1. Methods: Payment forms via LiqPay or other payment services published on the Organization's website; Direct transfer to the Organization's IBAN.

4.2. The donation is irrevocable and non-refundable, except in cases directly provided by the legislation of Ukraine.

4.3. Transaction fees of payment systems are paid according to their terms and conditions.

4.4. If the requirements set forth by applicable law or the rules of the payment system are not met (e.g., missing required information or documents), the funds may be automatically refunded to the payer within 60 days.

#### **The Organization has the right to:**

- Independently determine the directions for using the funds unless otherwise specified by the Donor;
- Amend the terms of this Offer in accordance with Section 9.1.

#### **The Organization undertakes to:**

- Use the donations in accordance with the laws of Ukraine and the Organization's Charter;
- Keep records of received funds and regularly publish reports on their usage on the website;
- Inform Donors, where possible, about the implementation of programs supported by their contributions.

#### **The Donor has the right to:**

- Make a donation voluntarily and in any convenient way;
- Specify the purpose of the donation (specific program or direction);
- Receive information about the use of the donated funds;
- Withdraw consent to the processing of personal data.

#### **The Donor undertakes to:**

- Provide accurate information when filling in payment or contact forms;
- Not demand a refund of the donation, unless otherwise provided by law.

## **6. Acceptance of the Offer**

6.1. Full and unconditional acceptance is considered to be the Donor's payment action (clicking the “Confirm Payment” button, subscribing to a recurring payment, or directly transferring funds to the Organization’s account). The date of crediting the funds is the date of conclusion of the Agreement.

6.2. Acceptance signifies the Donor’s agreement with all terms of this Offer.

## **7. Processing of Personal Data**

By making a donation, the Donor provides consent to the Organization to process their personal data for the purpose of executing this Agreement and complying with accounting and financial monitoring legislation.

## **8. Liability and Dispute Resolution**

8.1. The Parties shall be liable within the limits of current legislation of Ukraine.

8.2. Disputes shall be resolved through negotiations, and in case of failure to reach an agreement — in courts under the jurisdiction of Ukraine.

## **9. Final Provisions**

9.1. If any provision of the Offer is declared invalid, the remaining provisions shall remain in force.

9.2. The Organization has the right to amend the Offer by publishing the updated text on the website. The changes come into effect from the date of publication unless otherwise specified.
