

PUBLIC OFFER

for the Provision of Individual Online English Lessons
Effective as of: February 18, 2026

This Public Offer (the "Offer") constitutes an official proposal by Sole Proprietor Olena Chepurna, registered as an Individual Entrepreneur (FOP) in Ukraine, Registration Number: 3149508142 (the "Teacher"), to enter into a legally binding service agreement under the terms set forth below.

This Offer is governed by the laws of Ukraine.

Acceptance of this Offer forms a legally binding Agreement between the Teacher and the Student.

1. Definitions

- 1.1 Teacher – Sole Proprietor Olena Chepurna.
 - 1.2 Student – an individual who accepts this Offer.
 - 1.3 Lesson – a 60-minute individual online English session.
 - 1.4 Long-Term Program – a structured program consisting of 24 individual lessons.
 - 1.5 Express Format – 1-10 individual lessons focused on short-term goals.
 - 1.6 Materials – proprietary educational resources created by the Teacher.
 - 1.7 Agreement – the binding contract formed upon acceptance of this Offer.
 - 1.8 Force Majeure – circumstances beyond reasonable control of either party.

2. Acceptance of the Offer

- 2.1 The Offer is accepted upon:
 - payment for any lesson or monthly program; or
 - participation in a scheduled lesson.
- 2.2 The Agreement becomes effective upon receipt of payment.
- 2.3 By accepting this Offer, the Student confirms legal capacity and full acceptance of all terms.

3. Age Requirement

3.1 Services are provided only to individuals 18 years of age or older.

3.2 Acceptance confirms compliance with this requirement.

4. Subject of Agreement

4.1 The Teacher provides individual online English lessons.

4.2 The Student agrees to pay for selected services.

4.3 Services are educational and do not constitute academic certification.

5. Course Formats

5.1 Long-Term Program

- 24 individual lessons
- Intensive Plan (3 months)
- Steady Plan (6 months)
- Paid monthly in advance
- Full 24-lesson prepayment is not accepted

5.2 Express Format

- 1-10 individual lessons
 - Paid per lesson
 - Scheduled in advance
 - Not part of Long-Term Program

6. Trial Lesson

6.1 One complimentary 60-minute lesson.

6.2 Does not create obligation for continuation.

7. Pricing & Payment

7.1 Price per lesson: 1000 UAH (or equivalent in USD at time of payment).

7.2 Payment is due monthly in advance for Long-Term Programs.

7.3 Payment obligation is fulfilled only upon receipt of funds to the Teacher's official business account.

7.4 Prices may be updated; the valid price is the one published at the time of payment.

8. Payment Processing

8.1 Payments may be processed via Ukrainian bank transfer, Stripe, Wise, PayPal, or other authorized providers.

8.2 Payment providers process card and financial data independently.

8.3 Currency conversion and transfer fees are borne by the Student.

9. Refunds

9.1 Refunds are governed by the separate Refund Policy published on the website.

9.2 Conducted lessons are non-refundable.

9.3 Refunds apply only to unused prepaid lessons within the current paid month.

10. Scheduling & Cancellation

10.1 Lessons are conducted at a fixed weekly time slot agreed in advance.

10.2 Floating schedules are not available.

10.3 Cancellation requires at least 24 hours' notice.

10.4 Cancellations made less than 24 hours before the lesson are considered completed.

10.5 Late arrival does not extend the lesson duration.

11. Intellectual Property

11.1 All Materials and methodology are the exclusive intellectual property of the Teacher.

11.2 Materials are provided for personal educational use only.

11.3 Recording, copying, distribution, resale, or commercial use is prohibited without written consent.

12. Confidentiality & Data Protection

12.1 Personal data is processed in accordance with the Privacy Policy.

12.2 The Teacher acts as data controller where applicable.

12.3 EU Students are protected under GDPR.

12.4 International payments are processed by authorized providers under applicable regulations.

13. Professional Conduct

13.1 Both parties agree to maintain respectful and professional communication.

13.2 Lessons focus exclusively on educational matters.

13.3 Lessons do not constitute legal, financial, or psychological advice.

14. Limitation of Liability

14.1 No guarantees are provided regarding exam results, employment, or specific language level.

14.2 Results depend on Student effort.

14.3 Liability is limited to the amount paid for the relevant lesson or prepaid month.

15. Termination

15.1 The Student may terminate the Agreement by written notice.

15.2 The Teacher may terminate the Agreement in case of violations, misconduct, or repeated cancellation breaches.

16. Force Majeure

16.1 Neither party is liable for failure due to Force Majeure events.

16.2 Such situations are resolved reasonably and individually.

17. Electronic Agreement

17.1 Payment or participation in lessons constitutes electronic acceptance.

17.2 Email correspondence constitutes valid contractual communication.

18. Dispute Resolution

18.1 Parties agree to attempt amicable resolution first.

18.2 The Agreement is governed by Ukrainian law.

18.3 Disputes shall be resolved in accordance with applicable jurisdiction.

19. Amendments

19.1 The Teacher may update this Offer.

19.2 The version published on the website is the valid version.

20. Entire Agreement

20.1 This Offer, together with the Refund Policy, Privacy Policy, and Student Rules Summary, constitutes the entire agreement between the parties.
