- Art show: Start small but captivating. Ask Mars to help curate local artists. In the fall?

We have to agree to assigned roles, along with what we are agreeing to do as a board member. Once we get funding, we need to have the roles listed out. We need a standard rate (\$25/hr?) We will further this discussion in the next meeting.
